

## **St. Louis Children's Hospital Foundation** **Blooms & Butterflies Raffle Official Rules**

The St. Louis Children's Hospital Foundation ("Sponsor") is conducting a brunch event entitled "Blooms & Butterflies" being held on April 13, 2022 at Old Warson Country Club, St. Louis, Missouri ("Event"). Drawings for a Hermes watch, Adam Foster jewelry piece, Nayak Plastic Surgery Package, Yves St. Laurent purse, and Dior X Blooms & Butterflies Tasting will be conducted at the Event ("Raffle").

**1. Eligibility:**

Participants must be legal resident of the United States of America who are 18 years or older.

**2. How to Enter:**

The Raffle begins at 8:30 a.m. CST on February 14, 2022 and ends at 11:30 a.m. CST on April 13, 2022. You may enter the Raffle via either the on-site or online entry methods described below. You may purchase as many Raffle tickets as you like and enter them into any of the on-site Raffle entry boxes at Old Warson Country Club on the day of the Event. All entries must be received by 11:30 a.m. CST of the last day of the Raffle, i.e., April 13, 2022. Proof of depositing entry in mail is not considered proof of delivery or receipt. No photocopied or mechanically reproduced entries will be accepted. Illegible, incomplete and duplicate entries will be disqualified. Entries will not be accepted from post office boxes. All entries become the property of Sponsors and will not be returned.

- a. **On-Site Entry Method:** Beginning on April 13, 2022, you may enter the Raffle by completing an Official Entry form (including your name) available, while supplies last, at the registration table at Old Warson Country Club and depositing it in a Raffle entry box.
- b. **Online Entry Method:** Beginning on February 24, 2022, you may also purchase Raffle tickets at [StLouisChildrens.org/Blooms](https://StLouisChildrens.org/Blooms). Each transaction recorded through the website will equal one printed ticket to be distributed to you at the event. You must place the paper Raffle ticket (which serves as the Official Entry form) in the appropriate item's Raffle entry box to be entered into the drawing.

**3. Prizes and Approximate Retail Value:**

There will be 20 Prizes awarded. The Prizes consist of a Hermes watch, an Adam Foster jewelry piece, a Nayak Plastic Surgery Package, a French inspired gift basket, an Yves St. Laurent purse, and the 15 centerpieces used to decorate the tables. The approximate total retail value of each Prize is:

- Hermes Watch - \$4,500
- Adam Foster Jewelry - \$1,300
- Nayak Plastic Surgery Package - \$3,500
- French Inspired Basket - \$500
- Yves St. Laurent Purse - ~\$1,300
- Dior X Blooms & Butterflies Tasting - \$5,000
- Centerpieces - \$80 each
- The total value of all Prizes to be awarded is \$17,540.

Prizes cannot be redeemed for cash. Sponsor reserves the right to substitute a comparable prize of like or greater value, including cash, for any Prize, or to change the date of the Event for any reason. The winners are responsible for all local, county, state and federal taxes on Prizes based on the value of the Prizes set forth in these Official Rules. The value of the Prize is considered taxable income to the recipient and may be subject to income tax reporting and/or withholding requirements in accordance with IRS guidelines.

**4. Selection of Winners:**

Winner(s) will be selected by a random drawing from among valid entries on or about April 13, 2022. Only one (1) winner will be picked for each Prize. Winners' names will be announced beginning at or around 11:45 a.m. CST on April 13, 2022.

Odds of winning depend on the number of Official Entry forms received.

Winners must be present to win. If Winners are not present at the time of the announcements, the Prizes will be awarded to an alternate Winner selected by random drawing. All claims for Prizes expire on April 20, 2022 at which time Prizes must be either claimed by Winner, or Winner shall arrange, with a third party, for the pick-up and delivery of such Prize.

The Raffle is governed by the laws of the United States and, by entering; all Winners and participants hereby submit to the jurisdiction and venue of the federal, state and local courts located in St. Louis, Missouri. The St. Louis Children's Hospital Foundation reserves the right to disqualify any participant who violates these Official Rules. **CAUTION: ANY ATTEMPT BY YOU TO UNDERMINE THE LEGITIMATE OPERATIONS OF THE RAFFLE IS A VIOLATION OF CRIMINAL AND CIVIL LAWS, AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSORS RESERVE THE RIGHT TO SEEK DAMAGES FROM YOU TO THE FULLEST EXTENT PERMITTED BY LAW.**

Sponsor and each of its respective affiliates, subsidiaries, parent corporations, and their respective officers, directors, shareholders, employees and agents, are not responsible for any incorrect or inaccurate entry information, theft, tampering, destruction, or unauthorized access to, or alteration of entries; printing or other errors; and any entries or mail which are late, lost, delayed, incomplete, misdirected, stolen, mutilated, illegible, postage due or any combination thereof. Sponsors reserve the right to modify, suspend or terminate the Raffle for any reason whatsoever. In the event the Raffle is terminated early, a Winner will be selected from all eligible entries received at the time of termination.

**7. Release of Liability:**

By participating, Winner and participants agree to release, discharge, indemnify and hold harmless Sponsors and each of their/its respective affiliates, subsidiaries, parent corporations, and their officers, directors, employees, representatives and agents from and against any claims made by the Winner, participants or any other third parties related in any way to the operation of this Raffle, as well as any other claims, damages or liability due to any injuries, damages or losses (whether alleged, threatened or actual) to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in any Raffle-related activity or participation in this Raffle.
